Business visas are issued in 48 hours minimum and they are just for ONE entry in Cuba for a maximum stay of 30 days. Longer stays will require extensions made in Cuba.

**MAIN INFORMATION OF PAYMENT METHODS**

All consular services carried out by post or courier, require an additional non-in person fee of £19, paid only once for one or more persons.

IN PERSON: cash, postal orders and banker's drafts payable to **HAVIN BANK** are accepted. Personal cheque are not accepted.

BY POST: postal orders and banker's drafts payable to **HAVIN BANK** are accepted. Cash and personal cheque are not accepted.

Please: enclose a pre-paid self addressed envelop for the return of your documents as the non in person fee does not cover the postage costs of their return. We recommend the use of recorded mail or special delivery.
